

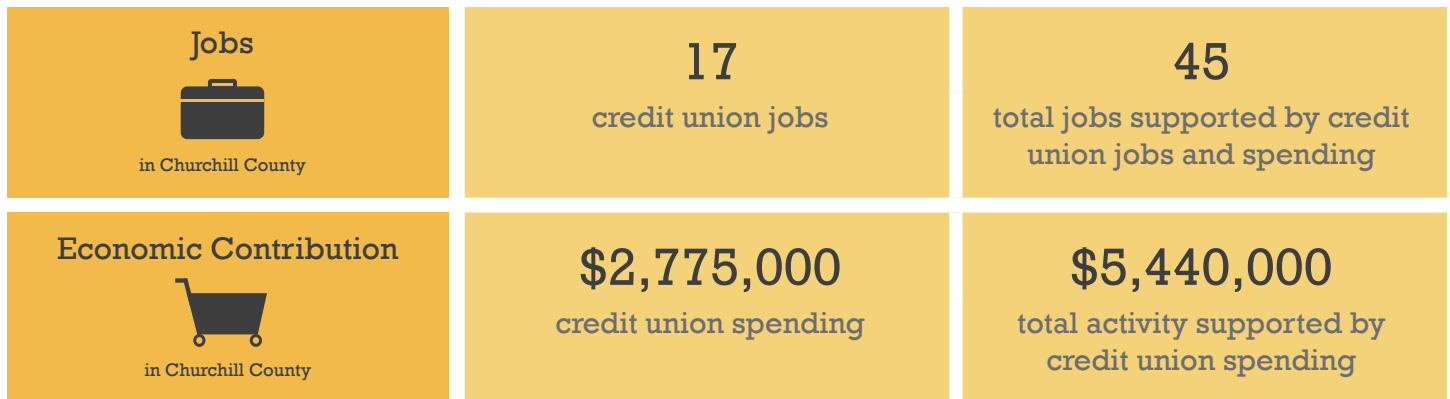
2016 Credit Union Economic Impacts

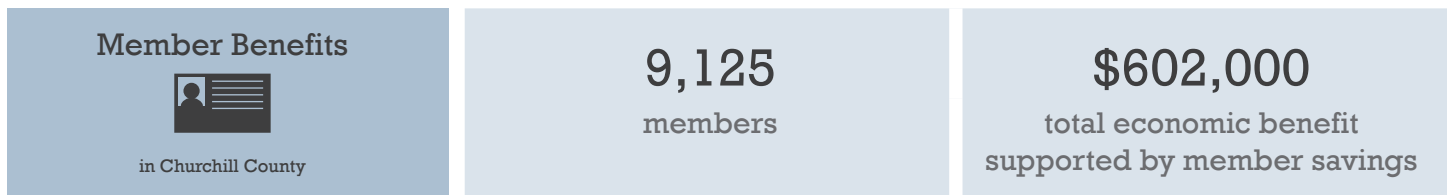
Credit Union Benefit to the Local Community
