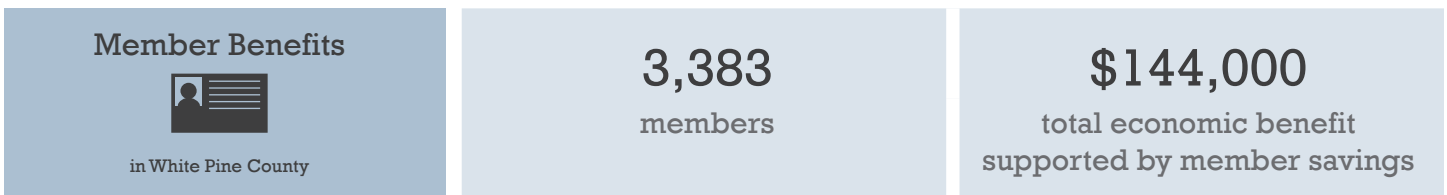
Credit Union Benefit to the Local Community
